4. The purpose of the register

- Customer surveys
- Enrolment for events
- Information of the authority services
- Implementation of the marketing prohibitions referred to in legislation

Handling of the given information is based on management of the customer relationship, on agreement of the registered person or to implement the legitimate interests of the holder of the personal data register.

5. The information gathered into the register

The register will handle required information necessary for its use:

- Contact information: Name, address, E-mail, telephone number.
- Demographic information: Gender
- Subjects of interest and behavior on the register holder's www-sites and services.
- Additional information provided by the client

6. Data sources

Personal data will be collected from the registered persons themselves during campaigns, feedbacks, questionnaires, or event registrations.

7. The disclosure and transfer of information

The information will not be handed over without the consent of the registered person in other than legally permitted and required situations, or by the means required by the authorities.

In order to manage tasks in line with the registery's use, subcontractors may be used and information may be transferred outside EU/EEA-areas, if it is necessary in order to implement the necessary service. In such case the holder of the personal data register will, by the means of contracts, take care of an adequate level of data protection as required by the legislation.



8. Data storage time

The holder of the personal data register will storage the information only for the time it is needed in relation to the purpose of use for the register.

9. Register protection

Databases, in which the information is stored, are technically and physically protected in a way that makes them inaccessible from the outside. Only the people who need the said information to complete their given work have access to them.

10. Right to inspection, correction and the right to remove the personal data

The registered person has a right to take back his/her given answer whenever they wish.

The registered person has a right to check what information has been stored about him/her, a right to require correction to wrong personal data, and a right to get information of themselves removed from the register.

A request for a checkup, correction or removal must be sent in writing and signed to the person who is responsible for the register.

11. Distribution and prohibition rights

The registered person has a right to get any personal information about him-/herself, which he/she has delivered to the person who is responsible for the register, in an analyzed form which is generally used and can be read mechanically, if the handling is based on an approval or an agreement and the handling will be carried out automatically.

The registered person has a right to limit the handling of his/her information, according to the EU's general data protection regulation, 18 Article.

12. Modification of the register

The holder of the personal data register reserves the rights to update and modify the Privacy Policy Information. If the legislation so requires, we will inform the registered person.
