Relocation services of the Fast Track campaign

## 4. Purpose of personal data processing

Personal data is used to implement relocation services and to request for feedback and follow-up information from IT and gaming professionals moving to Finland and from their families. The register consists of personal data of those participating in the campaign and using the relocation services. The processing of data is based on the consent of the person.

## 5. Data content of the register

Contact information: name, email address, telephone, employer and the relocation municipality in Finland. Other information provided by the customer necessary for the handling of the matter. You can give feedback about the services.

## 6. Regular data sources

The sources of the information are the sourcing partner of the Fast Track campaign in the United States and the HR partner of the campaign in Finland, as well as the individuals themselves. A sourcing partner obtains personal information from individuals themselves and passes it on with the person's permission.

## 7. Regular disclosure of information

The employees of the ELY Centre who are responsible for the implementation and monitoring of the Fast Track campaign, as well as the employees of the service provider providing the relocation services have access to the information in the register. The service provider processes personal data in order to provide individual and high-quality relocation services. The service provider will release/destroy personal data after the end of the service. The data will not be disclosed without the consent of the data subject, except to the extent permitted and required by law.

## **8. Regular disclosure of personal data or transfer of data outside the EU or the EEA**

Transferring data outside of the EU or the EEA.

## **9. Principles of register protection**

The databases in which the data are stored are technically and physically secure, so that they cannot be accessed from the outside. Access to information is restricted to those who need it to perform their duties.

## **10. Right of inspection**

The data subject can cancel his or her registration at any time. Consent to the processing of data may be revoked by sending a free-form message to a contact person or by email or by post.

The data subject has the right to:

- check what personal information about him or her has been stored in the register
- get incorrect personal information corrected
- have their data removed from the register
- restrict data processing
- transfer data from one system to another.

The request must be sent by email or by post. The reference "Pohjois-Savon ELY-keskus, Fast Track -kampanjan tietojen tarkastuspyyntö" ("North Savo ELY Centre, Fast Track campaign data verification request") must be added to the message. The name of the contact person (Vesa Liesivuori) should also appear in the request.

The data subject also has the right to lodge a complaint with the Data Protection Ombudsman.

## **11. Right to demand rectification of data**

The data subject has the right to demand the correction of his or her incorrect personal data.

The request is to be addressed to the ELY Centre at [kirjaamo.pohjois-savo@ely-keskus.fi](mailto:kirjaamo.pohjois-savo@ely-keskus.fi) or sent by post.

## **12. Other rights related to the processing of personal data**

The information will not be used for direct mail advertising, distance selling or other direct marketing.

The data controller reserves the right to update and amend the privacy statement. If required by law, we will notify data subjects.
